- 1.1. CONTRACTOR TO COORDINATE WORK WITH PARKS CANADA ARCHAEOLOGISTS AND ENGAGE RECORDING ARCHAEOLOGISTS AS
- 1.2. CONTRACTOR TO COORDINATE WORK WITH PARKS CANADA REPRESENTATIVES.
- 1.3. CONTRACTOR TO SURVEY SITE.
- 1.4. CONTRACTOR TO HIRE A PROFESSIONAL ENGINEER FOR LIFTING DESIGN.
- 1.5. CONTRACTOR TO UNDERTAKE PHOTOGRAPHIC DOCUMENTATION.
- 1.6. CONTRACTOR TO ALIGN AND STRAIGHTEN BUILDING-PROPOSED PROCEDURE.
- 2. THE FOUNDATION IS TO BE CONSTRUCTED SUCH THAT THE WALL TOP AND BOTTOM PLATES ARE CONSISTENT IN ELEVATION IN EACH OF THE THREE SEPARATE BUILDING SEGMENTS. THE TOP OF FOUNDATION WALL IN EACH OF THE THREE SEGMENTS IS INDICATED ON THE DRAWINGS BUT MUST BE CONFIRMED THROUGH MEASUREMENTS TAKEN ON SITE BY THE CONTRACTOR WHEN THE BUILDING IS LIFTED.
- 3. ALL CONCRETE VISIBLE TO VIEW SHALL BE EXPOSED AGGREGATE FINISH TO PROVIDE A "WEATHERED" OR "BUSH HAMMERED" APPEARANCE. USE MAXIMUM 20 MM ROUND AGGREGATE. REFER TO BLACKSMITH SHOP NEARBY AS A REFERENCE.
- 4. PORTIONS OF THE ORIGINAL BUILDING FOUNDATION THAT ARE DISCOVERED DURING BUILDING LIFTING AND EXCAVATION FOR THE NEW FOUNDATION MUST BE PROTECTED, CAREFULLY DOCUMENTED PHOTOGRAPHICALLY WITH RESPECT TO DIMENSIONS AND POSITION AND THEN ACCOMMODATED IN THE RELATIVE LOCATION AND CONFIGURATION IN THE NEW FOUNDATION. REFER TO DETAILS ON PAGE S11.
- 5. ALL EXCAVATION TO BE CARRIED-OUT WITH HAND TOOLS ONLY DUE TO POTENTIAL DISCOVERY OF ARCHAEOLOGICAL ARTIFACTS. SEE SPECIFICATIONS FOR FURTHER DETAILS.
- 6. FOR TOP OF GRADE BEAM LOGIC SEE BELOW.

- TOP OF GRADE BEAM AT THIS POINT IS 150mm HIGHER

7. TOP OF GRAVEL IS TO BE 50mm LOWER THAN TOP OF GRADE BEAMS EXCEPT FOR AT DOORS. AS THE LEVELS OF GRADE VARY, THE DEPTHS OF GRAVEL WILL VARY.

- THE NEXT LOWER HEIGHT OF GRADE BEAM IS DETERMINED AGAIN BY THE MEASURED DISTANCE BETWEEN THE BOTTOM OF NEW SILL PLATES OF SECTION 1-1 AND THE BOTTOM OF NEW SILL PLATES OF SECTION 1-2. THE DRAWINGS HAVE ASSUMED THIS MEASURED DISTANCE TO BE 22mm. THIS IS TO BE CONFIRMED ON SITE.





- 4. THE WALL STRUCTURE VARIES ALONG THE NORTH WALL. SEE SECTIONS H, J, K, L OF PAGE 17 OF THE HERITAGE RECORDING DRAWINGS FOR DETAILS. FOR OTHER WALL DETAILS, SEE BUILDING SECTIONS A-A THROUGH G-G OF THE HERITAGE RECORDING DRAWINGS.
- 5. REINFORCING OF THE ROOF RAFTERS SHOULD BE UNDERTAKEN DURING THE WORK PROCEDURE AT A TIME WHEN THE EXISTING RAFTERS ARE STRAIGHTEST IN ORDER TO BEST AND MOST EASILY SISTER THESE MEMBERS. - 6. REMOVAL OF EXISTING TEMPORARY STABILIZATION MEMBERS IS TO BE UNDERTAKEN WITH CARE. DRAWN LOCATIONS OF TEMPORARY STRUCTURES ARE APPROXIMATE AND MAY VARY ON SITE. NUMBER OF POSTS MAY VARY.
- 7. WHEN GRADE BEAM IS COMPLETE, BACKFILL AND COMPACT EXISTING GRADE TO 98% SPDD. INSTALL GEOTEXTILE OVER ENTIRE MAIN FLOOR AREA. ADD GRAVEL (ROAD CRUSH) IN 200mm LIFTS MAXIMUM AND COMPACT TO 98% SPDD. INSTALL WOOD BOARDWALK ON 200mm COMPACTED GRAVEL AND THEN INSTALL REMAINDER OF GRAVEL TO 50mm BELOW TOP OF GRADE BEAM. RAMP UP TO DOORS AND BOARDWALK.






