#### Editor's Note

This manuscript was presented by Margaret Angus in 1965. In preparing it for printing the format of the entries has been altered to provide a degree of uniformity and an index of names has been omitted. With these exceptions the text is virtually unchanged. In reading the tables which occur frequently in the manuscript the sums of money appearing in the 6th column are in pounds, shillings and pence unless otherwise indicated. William Kirby in his <u>Annals of Niagara</u> speaking about the time after the burning of Niagara in 1813 says:


The first building of any importance re-erected in this town was the new district gaol and court house - built a mile and a quarter from the centre of the town and quite too far for the convenience of people having to attend the courts, as they had to find quarters in the various hotels. The building was of brick, large and well adapted to the purpose.


[NOTE: In 1846 a new Town Hall was built on the market place, Queen Street and it was also used as the court house.

In 1870 Miss Page bought the old gaol and court house for use of the orphan and destitute girls she brought out from England.]



(<u>History of Niagara</u>, p. 115.) The brick house occupied by G. Bernard, at the corner of the Centre and Mississauga Streets was the residence of John Breakenridge.

(<u>Niagara Herald</u>, 1828.) "Died John Breakenridge, Esq., Barrister etc.

Niagara has lost one of its best friends. He settled here shortly after
the war and built several of the most elegant and tasty homes in town."

(Ibid., 18 Sept. 1828.) Auction - to be sold at the house of Mrs. Breakenridge, in Niagara, on Tuesday 23<sup>rd</sup> September,

2 cows - 1 cart and harness

1 sleigh and 1 sett of harness

Together with sundry articles of household furniture.

(Ibid., 11<sup>th</sup> January 1829.) Mrs. Fenwick and Mrs. Breakenridge will re-open their school.

(Ibid., 1830 [advertisement].) Niagara Seminary for young ladies, taught by Mrs. Fenwick and Mrs. Breakenridge.

(Ibid., 1833 [advertisement].) Mrs. Breakenridge "hopes for a continuance of public favour" and suggests "the additional claims of a long residence in the town, heavy misfortunes, a large family to maintain, and her experience for four years with Mrs. Fenwick."

(<u>Niagara Gleaner</u>, 24 August 1833.) Mrs. Breakenridge's Seminary for young ladies will be re-opened 26<sup>th</sup> August.

(Ibid., October 12, 1833.) Sheriff's sale - in suit of William Warren Baldwin and Robert Baldwin against lands now in the hands of Mary Warren Breakenridge - have seized Town lot 202 and all buildings thereon for sale Jan. 1834.

(Niagara Chronicle, June 28, 1845.) For sale, the two storey brick

dwelling house and lot containing one acre of ground, with offices, outhouses, etc., at present occupied by D. McDougall Esquire, Treasurer of the Niagara District. The house has been constantly let since the proprietor ceased to reside there, a period of 9 or 10 years. For information as to terms apply to Messrs. Stevenson and Robinson, barristers, St. Catharines; or to the subscriber at his office in Kingston.

to the United States before July 1, 1812.

[NOTE: one record gives assign date as 1816.]


1857. Thomas Courtney to Thomas Courtney Jr. and his wife (Patience). "Lot  $12 - \frac{1}{2}$  acre on which new house stands."

[NOTE: <u>Niagara Gleaner</u>, 1832, identifies Thomas Courtney as a carpenter - he is listed in the District of Niagara account with the Teasurer as being paid for making coffins.]

Thomas McCormick's sale of this lot to Thomas Courtney for £62.10/, exactly what McCormick paid for it ten years earlier, would seem to indicate that there was no building here before 1832 - or shortly before, when Courtney took possession.

(Niagara Gleaner, 1823.) Cannan's [sic] Inn mentioned in advertisement for lost article. Also mentioned in a location given as Second's Inn and Cannon's Inn.





(Oral Sources.) said to have been dwelling, school, in double dwelling. Possibly moved back to present location, c. 1915.

(<u>History of Niagara</u>, p. 113.) 1838 advertisement of William Moffatt for tavern, "The Sign of the Crown," 8 bedrooms, 2 dining rooms, stabling, etc. (2 storey) opposite Lewis Donnelly's [he was on lot 110] later

became York Academy of Mr. Chas. Camidge [1871].

1815, John and Eliza Campbell to Robt. and Peter McDougall.

1830, Peter McDougall (of Toronto) to Jared Stocking, 1 acre and all houses.

(Niagara Chronicle, May 22, 1838.) An evening school will be opened at Mr. Platt's house (formerly William Moffat's Tavern) and instruction given in writing, arithmetic and the usual branches of an English education. A French class will also be opened.

[NOTE: 1843, Platt bought out part of Lot 110]

(Ibid., May 7, 1838.) Writ against Jared Stocking, John Grier and Charles Koune - Lot 20, part of lot 100, lot 109, part of lot 71, lot 288, S/W half of lot 13, lots 139 and 140 with all buildings.

(Ibid., November 1, 1843.) To let also - in Johnson Street, one house with 8 rooms, and a new house  $30 \times 40$  feet which has never been occupied, with every convenience for a hotel or private residence.



Parlour fireplace similar to one in Green House. Stairwell altered to allow more head room. Early floors. Some 1835 trim changes. House possible result of two periods - early 1820s and mid 1830s. Six rooms plus basement kitchen and rooms.

Clement, Melbourne, Newman.

(Niagara Gleaner, 1823) [2 Notices]. Sheriff's sale of lands of late Colin McNabb which have descended to John McNabb, at the suit of John Muirhead. [amongst others]. Lot 110 and 143, Town of Niagara, 1 acre each.

(Ibid.) Sheriff's sale of lands of Colin McNabb, lot 110 with the house and appurtenances thereon; and lot 143 in the Town of Niagara. [NOTE: The land and house were sold to James Muirhead whose wife, Deborah, was the only daughter of Colonel Butler. Before the deal was completed their only child John Butler Muirhead had died and a year later James Muirhead was dead.

Lewis Donelly had a Tavern in the building by 1838 and had been there long enough to be used as a landmark to locate a new tavern across the street.]





(Oral sources.) Miss Ball says her father thought the house had been built sometime in the 1849s [but a building appears to be indicated on 1817 map.]

(<u>Niagara Gleaner</u>.) Died at Niagara. July 28, 1823 Mrs. Pilkington, wife of Dr. Pilkington.

[No indication of a house on this lot until the 1840s when Alexander Davidson bought it and lost it through foreclosure of mortgage.

Charles Hall who obtained the title through a foreclosure, died in February, 1849 leaving his wife and two daughters. The Hall daughters, Sarah, who married Robert Campbell, and Isabella sold the property in 1887.]



#### Documentation

Ralph Clench - elected Town Clerk, 1793; Judge of Surrogate Court, 1803; Member of Parliament, 1806-1810; staff of Quarter Master Department, Upper Canada Militia, 1812.

1813. House was one of two to survive the burning of the Town. Shared it with the Alex. Stewart family, who were cousins, until it was burned by accident shortly after. Second house built c. 1826.

Clench married Elizabeth Johnson, daughter of Capt. Brant Johnson and grand daughter of Sir Wm. Johnson. Children: Margaret; Hannah; Priscilla, F.A.B.

Eric Arthur - pamphlet re. small houses.

(Ibid.) Ralph Clench died January 9, 1828, age 66. He was a native of Schenectady who joined the British forces in 1777.

(Ibid., March 13, 1828.) Margaret, eldest daughter of the late R. Clench married Richard Bullock.


(Ibid.) The sale of the property - Elizabeth Clench, widow, is to her children Francis A.B. Clench, Hannah and Priscilla.

(Ibid.) Elizabeth Clench died August 15, 1850, age 77. She was the daughter of Captain Brant Johnson and the grand daughter of Sir William Johnson.

John Young Crooks had a store adjoining his dwelling on Queen Street (Niagara Gleaner, Feb., 1833). He died March 31, 1833, leaving a widow and five daughters; the eldest about 8, the youngest only a few weeks old. His widow, Mary, and William and James Crooks his executors advertised his shop and stores "in which the post office is now kept." (Niagara Gleaner, 1833).

J.S. Buchanan and Co. took over the store (Niagara Gleaner, May 1833) but Mrs. Crooks seems to have kept the house for some years. In 1849 the Misses Millard opened "a Seminary for Young Ladies in the house lately

occupied by Mrs. Crooks." (Niagara Chronicle, Sept. 1849.)

Lot 57 to which the house was moved belonged originally to John Willson and was inherited by Andrew Willson and Catharine Fitzgerald.

(<u>Niagara Mail</u>, 1848.) For sale in the town of Niagara lots 57, 58 and 59 on Queen Street. Apply to Miss. Fitzgerald.

(Ibid., July 22, 1850.) To lease for building, lots 57, 58, 59





A "new store one door north of Mr. R.M. Crysler's Store." (Niagara Gleaner, 1823.) In 1825 R.M. Crysler advertised to let the building adjoining his store, formerly occupied by L.C. Beardsley as a printing shop. (Niagara Gleaner, Oct. 22, 1825).

(Niagara Gleaner, June 1832.) An advertisement carried an illustration of Crysler's store. The plate of the engraving was evidently broken sometime later when it appeared first with a jagged break across the centre and was finally not used at all. The corner building presently number 154 Queen Street.

The editors comment in the same issue says, in part. "By an advertisement in our paper it will be seen that the enterprising Messrs. Crysler have greatly extended their business; and from the old and respectable character of the firm, there is no doubt of its receiving its usual patronage."

[NOTE: the advertising itself shows the plate illustrating the building and lists the goods for sale. The extension referred to is probably that on the building.]



For iron (129 lbs.) various amounts of stone (about 3 tons), screws, nails, labour, bolts, latches, 32 brass knobs, 1 brass door latch, 123 panes of glass 8 x 10, 41 panes of glass 7 x 9, etc.

(Davidson, <u>Reminiscences</u>.) Rogers house and the brick block of Blake and Rogers at the corner (see newspaper notes). Blake was John Blake who married Mary Rogers.

[NOTE: John Blake, Indian Agent, travelling to west in 1820s.]

(Niagara Gleaner, June 16, 1828.) Obituary of Mrs. Rogers. "...she left the north of Ireland 22 years ago with her husband and family amounting then to 6 in all. Her present descendants number almost 40."

(Niagara Gleaner, 1823.) The building called Alexander Rogers Hotel and Tavern in March 1816 was probably on Prideaux Street behind the lot 52 building. It was the older Rogers family building and would have been closer to the water. Mrs. Agnes Rogers, widow of Alexander continued to operate it as late as 1823.

(<u>Niagara Spectator</u>, October 16, 1817.) Advertisement dated July 14, 1817 dates the present 157 Queen Street. "Niagara Coffee House-James Rogers respectfully informs the public, that having completed his large and commodious House on Queen Street in this town near the centre of the village, he is now prepared to

entertain genteel company."

(October 18, 1818.) John Peter announced he had established a shaving and hair dressing business in the Bar Room of James Rogers Coffee Shop.

(Niagara Spectator, July 28, 1819.) James Rogers thanked the public for their encouragement of him as an inn keeper and said "His house having been considerably enlarged during the past year and other improvements made in proportion."

"Also to let - an excellent building for a store next door east of the Niagara Coffee House - a new building and in complete readiness for the mercantile business."

(Ibid., Sept. 26, 1820.) The Duke of Richmond Coffee House. The subscriber has taken that well known stand occupied and owned by the late James Rogers as the Niagara Coffee House..."

#### Charles Koune

(Niagara Gleaner.) Advertisement date October 29, 1823. "The subscriber has entered into possession of the house lately occupied by Charles Koune (The Richmond Coffee House) in this town, now the Coffee House, Signe of the Golden Ball, where ladies and gentlemen..."

#### L. Carroll

(Ibid., June, 1828) "Mr. Robert Gray is about opening an elegant house of entertainment in the House in Queen Street, formerly

occupied by Charles Koune."

(Niagara Herald, June 19, 1828.) Robert Gray has taken "that elegant and well known house, built and occupied as a hotel by the late Mr. James Rogers. The Niagara House is pleasantly situated on the main street and from its galleries can be had a view of the lake and river, the Fort and the dock..."

Adam Crysler had the Niagara House in 1830. The store mentioned in the <u>Niagara Spectator</u>, 1819 was replaced by a building (no longer standing) in 1838.

(Niagara Gleaner, October 19, 1833.) John Rogers and Co. have opened in part of the new three storey brick building lately erected on Queen Street, a mercantile...

[NOTE: This three storey building and the Rogers house are shown in an illustration in volume IV of Guillet's <u>Pioneer Inns and Taverns</u>.

Another illustration shows the earlier Charles Koun's [sic] Coffee House. It shows two doors, one the present far right window. The "James Rogers Hotel" illustration shows the one door with fanlight and sidelights as it is now.]



Adam Crysler's title to this property is dated April 24, 1820. His earlier store, in partnership with Long, which opened October 4, 1816, was not on this site. (Niagara Spectator). In the summer of 1818 the partnership was dissoved and each man went into business on his own. (Ibid.). In January, 1823 an apothecary was opening a shop "adjacent to Mr. Adam Crysler's Store and nearly opposite the post office."

(Niagara Gleaner) Adam Crysler (age29) died September 23, 1826 of consumption leaving a wife and two children. (Ibid.) On September 23, 1826 William L. Daly was authorized to settle the estate of Adam Crysler. (Ibid.) In 1828.

Daly was advertising "the well-known store belonging to the estate of the late Adam Crysler." (Niagara Herald.) Meantime Jared Stocking had occupied the store for a time. (Niagara Gleaner, 1825.)

It is not clear exactly when Daniel McDougal took possession of the property. He also had been in business since December 9, 1817.

(Niagara Spectator.) On May 12, 1824 D. McDougal advertised to let "the store he now occupies...he being fitting up the store joining his dwelling house for his own occupation." (Niagara Gleaner.)

The site of McDougal's store has not been identified.


In January, 1825, there was a meeting concerning plans for a public library held at McDougall's Inn. (Ibid.) This may have been the present 144 Johnson (lot 110) which belonged to the estate of McDougal's father-in-law, John McNabb.

In 1845 the McDougall's were about to leave the Breakenridge house, 240 Centre Street (see report on this house). It is likely that they moved at that time into this house although the title was dated March 7, 1849.



(<u>Niagara Spectator</u>, 1817.) Isaac Swayze had a house near Queenston which he advertised for sale February 27, 1817 saying it had 4 rooms etc. on 11 acres of land.

(<u>Niagara Gleaner</u>, 1823.) To let for a year or more that pleasantly situated house and premises 1 mile below Queenston, on the bank of the Niagara River. The house is large and commodious with the

convenience of a good dry cellar and fine garden, fruit trees and pasture land - 7 acres.


Isaac Swayze.

On February 11, 1828 Isaac Swayze died at his residence near Niagara, age 77. Francis and William Swayze were left lots 20 and 27 to be equally divided. In 1832 William Swayze advertised that he would sell stock, implements and furniture "at his residence on the River Road between Niagara and Queenston."







Appendix A: Niagara Gleaner

The following advertisment in the <u>Niagara Gleaner</u> dated July 13, 1830 is worthy of notice.

Sealed tenders will be received - - for a meeting house for the Baptist Church - "of the size and exactly upon the plan of the Methodist Meeting House in this town, viz: length, 42 feet, breadth, 32 feet. Height of posts (to the top of the plates) 20 feet, with an addition of a porch 10 feet by 7 feet of a proportionate height and an additional door on one side of the building.... The building must be enclosed by 15 November next. The timber can be obtained within five miles of the town. The materials for building, after the timber is hewed, will be furnished on the place of building.

# The Niagara Gleaner, July 20, 1833

Signs of the Times - From the progress of the erection of new buildings in our good town, it will be inferred (and truly so) that we are on the "march of improvement." Niagara is evidently "pushing ahead", as brother Jonathan would say. The Messrs. Rogers are far on the way with a 3 story brick building, and which will be the largest structure in this town. Mr. John Harris has completed a large 2 story building situated in King Street. Many other buildings have been put up within the last year - and the extensive premises of L. Clement & Sons are about receiving a very extensive wholesale grocery Establishment owned by Mr. P. Drummond, as will be seen by today's paper.

The Dock is progressing rapidly, owing, no doubt, to the spirited exertions of Capt. Melville - a gentleman to whom Niagara should consider itself greatly indebted.

# Niagara Herald, March 4, 1886

Fire started in large wooden building owned by Irving of Toronto and occupied by Messr R. Fuller, W.D. Webster & P. Lynch. North wind - & adj. barber shop & residence of Lewis Ross burned. Next caught Robt. Rogers then T.F. Bests' butcher shop - nothing to save block - unless Mr. Paffords Drug store on the corner might escape. Called Niagara Falls for help - special train ... Mrs. Sherlocks brick store and frame residence adjoining had been attacked, the flames creeping along the cornice and going through the roof. Arrival of Clifton brigade saved them, which as it was, were badly injured, the brick store in fact, being completely gutted.

Webster, watchmaker, lost quarter part of his stock and all his household effects. Lewis Ross - household effects saved. Building occupied by R. Rogers tailor & residence & T.F. Best, butcher, belonged to the estate of the late Adam Crooks.

Mrs. Sherlocks two bldg damaged but furniture & household effects were saved.

### Bibliographic Essay

In the preparation of this manuscript a variety of primary sources were examined. The Upper Canada Sundries (RG 5, A2) were studied at the Public Archives of Canada. Assessment rolls for the township of Niagara for 1847-1848 and for the town of Niagara from 1853 on are on microfilm in the Ontario Archives at Toronto and in manuscript in Niagara. Abstracts of Deeds came from the Registry Office in St. Catharines. In addition information concerning land ownership was drawn from H.R. Page's Historical Atlas of the Counties of Lincoln and Welland (1876) and a number of maps of Niagara dating from 1799 to 1850. Architectural details are from Peter Stokes' Inventory Sheets and notes of Francis Parker McKay.
